The ideas for the installations came from our QyouT group and community icon, Jenni Atkinson sat in on the discussions and was very impressed by the creativity of ideas, the written application and the risk assessments that went with that application with a support letter from SpringOut! Fingers Crossed!

Last month our Rainbow Christian Alliance, Dare Café group in Goulburn celebrated their 2nd Birthday. Our Canberra RCA group will be 3 in July; time has flown for this amazing group of LGBTIQ Christians, who now call this group their Church.

We have a pretty full schedule for the start of the year, including a guest speaker from Beyond Blue, making mini Japanese food kits, an evening with Tessa Devine and of course lots of food opportunities.

Several of our members, and the Canberra RCA group lodged submissions to the Ruddock inquiry. We are waiting with interest for the report from the inquiry, and we shall see where that takes us next.

LGBTIQ+ Canberra History – Bruce Moore

The ACT's Office for LGBTIQ Affairs is pleased announce that it has commissioned a history of LGBTIQ Canberra to celebrate the 50 years of achievement since the formation of Australia's first gay rights group, the Homosexual Law Reform Society, in Canberra in 1969. The book will be researched and written by Graham Willett, a historian of queer Australia whose works include *Living Out Loud: A History of Gay and Lesbian Activism in Australia* (Allen and Unwin 2000).

The history will begin with the very small camp scene which existed prior to 1969 and will continue up to the present. It will look at grassroots political activism, social life, and Territory laws, regulations and policy brought about by advocates within as well as outside the government apparatus. The focus is on Canberra as a community in its own right; one in which queer people of all kinds have lived and loved, danced and demonstrated, agitated and advocated.

The work is due to be completed by the end of 2018, and in the meantime Graham is keen to hear from and talk to anyone who has memories of LGBTI Canberra and is willing to share them. He can be contacted at gwillett@unimelb.edu.au

2018 is the fortieth anniversary of the Sydney Mardi Gras, and there has developed a narrative that sees this festival as the origin of gay political activity in Australia. However, the significant political activity began a decade earlier, and the ACT Homosexual Law Reform Society was at the forefront of this activity.

In *Sunshine and Rainbows* (2001) Clive Moore gives a short summary of the establishment of the ACT Homosexual Law Reform Society in 1969:

An Australian Capital Territory Homosexual Law Reform Society was formed in Canberra on 27 July 1969 at a meeting of thirty concerned people, although all of its spokespersons identified as heterosexual. They published a ten-page newsletter one month later. The Canberra Society was formed at the instigation of Australian National University (ANU) Philosophy lecturer Dr Thomas Mautner, who was disturbed by reports that a Canberra gay man had been jailed for six months on an indecent assault charge. The convicted man's solicitor Mr M A S Landale teamed up with Mautner and Dr Des O'Connor, ANU lecturer in criminal law, to form the Society. (p. 165)

- 1) Membership is open to anyone.
- 2) A family is defined as a family unit of up to 5 members living in the same household .
- 3) By making this application for membership, you understand you are applying for membership of Diversity ACT Community Services Inc (Diversity ACT). You agree with and support Diversity ACT mission statement of support, understanding, tolerance, respect and acceptance of all LGTBI members of the community.
- 4) Members are representatives of Diversity ACT who value and support its name in the wider community.
- 5) All membership is to be in accordance the Diversity ACT Association Rules, Diversity ACT Privacy Policy and any laws that govern the membership of an incorporated association in the Australian Capital Territory.
- 6) Membership does not become valid until it is approved by and announced at a committee meeting and fees are paid in full.
- 7) Membership is not refundable. Diversity ACT will make refunds of membership fees only where there has been an error in the amount paid for membership. The total amount of any refund will only be the amount required to reimburse an overpayment.
- 8) Memberships are non-transferable
- 9) Members are entitled to:
 - 9.1 Access and use facilities and services offered by Diversity ACT (some services have a cost)
 - 9.2 Attend Annual General Meeting (AGM) and vote to elect committee members
